Refund Policy: The full month's tuition is due if the student attends school any part (even one day) of the month. Regardless of payment plan, the full tuition amount will be divided by 10 months for the purpose of payment responsibility. All tuition payments are non-refundable except for when tuition is paid more than a month in advance. The student curriculum kit fee and all other fees are non-refundable.

Tuition Tax Credit and Scholarships: Parents with children enrolled at LCCA may claim a tax credit of up to \$1,000 for tuition expense.
