**Enrollment/Re-enrollment Fee** .....\$50

- An additional \$36 testing fee will be applied to new applicants.
- Re-enrolling students will have incremental registration increases beginning June 16.

### Tuition for grades 1 through 12

- For one student .....\$3,990
- For two students .....\$6,750

  - 1/2 credit .....\$300
  - 1/4 credit .....\$200

### **Before-School and After-School Care**

AM Charge	7:00-7:45 will be \$2.50 per day per child. 7:45-8:00 will not be charged.	Charges will be added to FACTS once a month.
PM Charge	3:15-4:15 will be \$3.00 per day per child. 3:15-5:15 will be \$6.00 per day per child.  ( <b>\$3.00 will be charged for each fifteen-minute period after 5:15 p.m.</b> )	

### **Sports Fees:** per sport/season

Junior High.....\$40	If an athlete participates on multiple levels within a particular season (i.e. on both a junior high and a junior varsity team), that athlete will be charged the lower fee.
Junior Varsity .....\$50	
Varsity .....\$60	

### **Other Costs:**

- PE uniforms (1<sup>st</sup>-10<sup>th</sup>) .....\$30
- Red & Gold Day (7<sup>th</sup>-12<sup>th</sup>).....\$50
  - 7<sup>th</sup> & 8<sup>th</sup> (optional)
  - 9<sup>th</sup>-12<sup>th</sup> (required)

**Refund Policy:** The full month's tuition is due if the student attends school any part (even one day) of the month. Regardless of payment plan, the full tuition amount will be divided by 10 months for the purpose of payment responsibility. All tuition payments are non-refundable except for when tuition is paid more than a month in advance excluding the first month's tuition. The student curriculum kit fee and all other fees are non-refundable.

**Tuition Tax Credit and Scholarships:** Parents with children enrolled at LCCA may claim a tax credit of up to \$1,500 for tuition expense. Nonacademic scholarships are available through the Buckeye Christian Scholarship Granting Organization (ohiosgo.org).
